

PROCESS TO GET *Your Own Franchise*

- Send us a letter of Intent that you are interested in operating the business
- We will then ask you to provide us with your resume and other information by you submitting the Initial Application Form (you may download it from your website)
- We will review the submitted Initial Application Form to assess if the business is right fit for you
- If you are successful, you will be provided with full disclosure documents
- You will have 14 days to review the disclosure document or get it reviewed with your attorney
- Once you have reviewed the document, you will sign it and deposit \$10,000 with the deposit agreement
- While preparing your franchise agreement, the location must be finalized as per the disclosure document, and the lease should be signed. It will take 2-4 weeks to prepare all your agreements
- Once the agreements are prepared, you will sign them and pay the remainder of the franchise fee
- We will sign the store development agreement and start the construction of the store. You will make the payments according to the development agreement
- Equipment, accessories and all required items will be ordered
- Your training process will start
- Grand opening support
